Know All Men by These Presents:

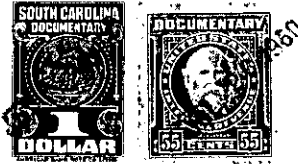
That we, David R. Pittman and Alice L. Pittman, of Greenville County,
