ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 26, as shown on a Plat of Laurel Hills by W. N. Willis, Engineers, dated March 1960 and recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 33, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Fairview Road, joint front corners of Lots Nos. 26 and 27 and running thence along the line of said lots, N. 69-12 W. 160 feet to iron pin line of Lot 24; thence running with line of said lot, S. 20-03 W. 122.3 feet to iron pin on Casa Loma Street; thence running with said Street, S. 80-27 E. 164.8 feet to iron pin corner of Casa Loma Street and Fairview Road; thence running with Fairview Road, N. 19-17 E. 90 feet to iron pin at point of beginning.

NO residence to cost less than Ten Thousand (\$10,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than thirty (30) feet, to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
