Know All Men by These Presents:

That I, M. W. Fore in the State aforesaid, in consideration of the sum of Six Hundred Eighty & NO/100 (\$680.00) - - - - -DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert A. Nobles and Doris E. Nobles, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 32, of a subdivision known as Section C, of Englewood Estates, as shown by a Plat thereof, dated December 1951, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 13, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Cherokee Drive at joint front corners of Lots No. 32 and 33 and running thence along the line of said Lot No. 33, S. 87-30 E. 175 feet to iron pin at back corner of Lot 51; thence along the rear line of Lot 51, S. 2-30 W. 75 feet to iron pin on Shasta Drive; thence running with the said Shasta Drive, N. 87-30 W. 150 feet to iron pin at curve; thence in a curve in a north-westerly direction 34.6 feet to iron pin on Cherokee Drive; thence with the said Cherokee Drive, N. 2-30 W. 50 feet to iron pin at point of beginning.

THIS deed is made to the following restrictions: No house is to be erected costing less than Five Thousand (\$5,000.00) Dollars; no house is to be built nearer than fifty (50) feet to the street; no temporary house is to be erected on said lot.

THIS deed is subject to any right-of-way of record.

GRANTEE to pay 1960 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
