to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, Otis Brothers, his heirs and assigns forever:

All of my right, title and interest in the following described property:

All of that certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, with the buildings and improvements thereon, being known and designated as Lot No. 4 of South Cherokee Park, as shown on a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book A at page 130, and having, according to said plat, the following metes and bounds:

BEGINNING at the corner of Lot No. 5 on the Grove Road and running thence with the line of that lot, S. 63 E. 172 feet to an alley; thence with said alley S. 27 W. 60 feet to the corner of Lot No. 3; thence with the line of that lot N. 63 W. 172 feet to Grove Road; thence with Grove Road N. 27 E. 60 feet to the beginning corner.

This is the same property conveyed by W. W. Brothers Jr. to Nannie G. Brothers by deed recorded in the R. M. C. Office for Greenville County in Deed Book 161, at page 46.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

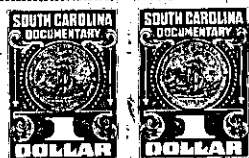
