

ALL That certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as 1938 Augusta Road, and more particularly shown on plat of property of Jas. K. Dobbs Co. of Columbia, Inc., prepared by Dalton & Neves, Engineers, in June, 1960, recorded in the office of the R.M.C. for Greenville County in Plat Book MM, Page 165, and having, according to said plat, the following metes and bounds, to-wit:
