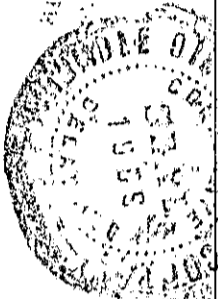
RELEASE OF LIEN
