All that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being on the Southwest side of Dupont Drive, in the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 97 on plat of Isaqueena Park, made by Pickell & Pickell, Engineers, June 3, 1947, recorded in the R.M.C.
