D. Shedd, his heirs and assigns forever:**

ALL that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot Nos. 42 and 43, of a subdivision known as Holly Vista, as shown by a Plat thereof, dated February 1956, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 191, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Arrowhead Lane, joint front corners of Lots Nos. 41 and 42 and running thence along the line of said, S. 31-12 W. 150 feet to iron pin rear line of Lot 45; thence running with rear line of Lots 44 and 45, S. 58-48 E. 97.1 feet to iron pin; thence running, N. 40-30 E. 152 feet to iron pin on Arrowhead Lane; thence running with Arrowhead Lane N. 58-48 W. 122.2 feet to iron pin at point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more, frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

GRANTEE to pay 1960 taxes.
