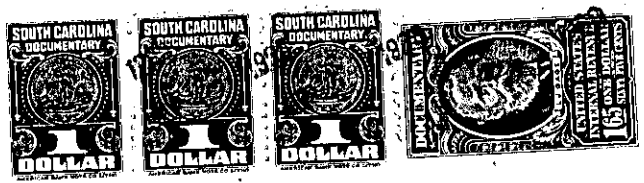
That I, WILLIAM R. TIMMONS, JR., in the State aforesaid,

acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto
the said TOMMY P. McLEES, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near
the City of Greenville, and being known and designated as Lot Number 9 of the property of Wm. R.
Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat
Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Avery Street at the joint front corner of Lots 8
and 9 and running thence S 28-56 E 173.4 feet to a point at the joint rear corner of Lots 8 and 9;
thence S 58-22 W 22 feet to a point at the joint rear corner of Lots 9 and 10; thence N 87-10 W 190.7
feet to a point on the Eastern side of Noble Street at the joint front corner of Lots 9 and 10; thence
with the Eastern side of Noble Street N 02-50 E 37 feet to a point; thence following the curvature of
the Southeastern intersection of Noble Street with Avery Street (the chord of which is N 31-57 E 87.3
