Johnson and her heirs and assigns forever:

All that parcel or lot of land in The Township of O Neal, County of Greenville, State of South Carolina, lying on the west side of Gail Avenue about three miles northwest of the City of Greer, being shown as Lot No. 52 on a subdivision known as VALLEYHAVEN ACRES, Section 4, made by John A. Simmons, Surveyor, July 15, 1960, recorded in the R.M.C. Office for Greenville County, having the following courses and distances, to-wit:

BEGINNING on a stake on the western margin of Gail Avenue, joint/corner of Lots Nos. 51 and 52 on said plat, and runs thence with the margin of said avenue, N. 24-53 E. 100 feet to a stake, joint corner of Lots Nos. 52 and 53; thence with the common line of Lots Nos. 52 and 53, N. 65-07 W. 200 feet to a stake on line of the Johnson land; thence with the line of that property, S. 24-53 W. 100 feet to a stake, joint corner of Lots Nos. 51 and 52; thence with the common line of Lots Nos. 51 and 52, S. 65-07 E. 200 feet to the beginning.

Subject to the right-of-way now held by Duke Power Company. Subject, also, to restrictive covenants as to the use of said property which are on file in the R.M.C. Office for Greenville County, reference to the record of same being expressly made for the details thereof.
