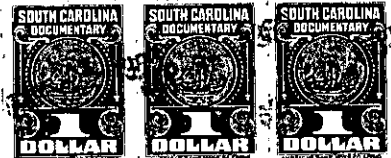
Harold A. Mullen, his Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, and being known and designated as Lot No. 26 in a subdivision known as Pecan Terrace as shown on Plat thereof recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "GG", Page 9, and being more particularly described according to a survey by Piedmont Engineering Service, August 18, 1954, as follows:

BEGINNING at an iron pin on the Southwest side of the White Horse Road, corner of Lot No. 25; thence with the line of said lot S. 53-16 W. 177.2 feet to an iron pin; thence N. 31-22 W. 65 feet to an iron pin in line of Lot No. 27; thence with the line of said lot, N. 51-30 E. 168.7 feet to an iron pin on the White Horse Road; thence with said Road S. 38-40 E. 70 feet to the beginning.

The above is the same property conveyed to the grantors by deed recorded in Deed Book 601, Page 290.

As part of the consideration of this conveyance the grantee assumes and agrees to pay the balance due on the note and mortgage given to the Canal Insurance Company dated August 19, 1954 and recorded in the R. M. C. Office for Greenville County in Mortgage Book 606, at Page 427, the balance now due and owing being \$10,358.84.
