In All Men by These Presents:

That I, - R. G. Turner, in the State aforesaid, DOLLARS,
in consideration of the sum of One Dollar, love and affection for my wife,
Mrs. Ollie Farnsworth

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Mary S. Turner, her heirs and assigns, forever:

AN UNDIVIDED ONE-HALF RIGHT, TITLE, INTEREST AND ESTATE IN AND TO--

All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, Chicks Springs Township, in the Town of Greer on the West side of Mostellar (now North Main) Street, bounded by lands of W. D. McCorkle, W. L. Hilton, and a new street (now Fairview Ave.) and having the following metes and bounds, to-wit:

Beginning at an iron spike (W. D. McCorkle's corner) on said Mostellar (now North Main) Street; thence nearly North with said street to intersection of Mostellar with said new Street (now Fairview Ave.) to a stone; thence nearly West with said new Street two hundred and thirty (230) feet to W. L. Hilton's corner, an iron spike; thence nearly south one hundred and five (105) feet to W. M. Thompson's corner, an iron spike; thence nearly East with W. D. McCorkle's line two hundred and thirty (230) feet to the beginning corner.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
