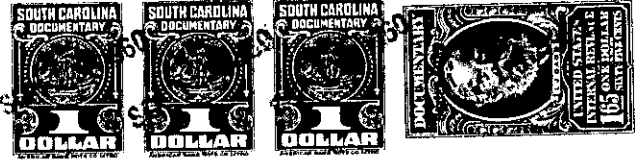
Know All Men by These Presents:

Childress in the State aforesaid, in consideration of the sum of thirteen hundred and fifty dollars (\$1350.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, James G. Brennan, his heirs and assigns forever:

All of that certain lot of land in Greenville County, State of South Carolina, being near the City of Greenville, and being known and designated as Lot No. 15 as shown on revised plat of Paris View which plat is recorded in the R. M. O. Office for Greenville County in Plat Book QQ at page 26, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on Montis Drive (formerly Paris View Drive) at joint front corner of Lots Nos. 15 and 16; thence along the joint line of said lots S. 70-54 E. 175 feet to an iron pin; thence S. 19-06 W. 82 feet to an iron pin at corner of Lot No. 14; thence along line of Lot No. 14, N. 70-54 W. 175 feet to an iron pin on Montis Drive; thence along said Drive N. 19-06 E. 82 feet to the beginning corner.

Said lot is conveyed subject to the following restrictions: 1. Said lot shall be used for residential purposes only. 2. Any house constructed thereon must contain at least 1200 square feet of floor space, excluding car ports and porches.
