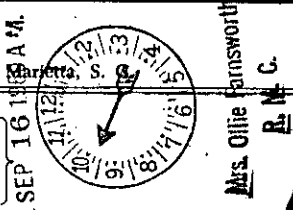

KNOW ALL MEN BY THESE PRESENTS, THAT I, H. A. Ables

in consideration of the sum of One and 00/100-----(\$1.00)----- in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Milton E. Ables and Annie Bell L. Ables, their heirs and assigns, forever:

all that piece, parcel or tract of land situate, lying and being in the County and State aforesaid, in the Shiloh community near Marietta, and having, according to a plat of survey of the Subdivision of Property of H. A. Ables, made by T. T. Dill, surveyor, July 5, 1960, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Bates line, joint corners of Tracts 3 and 4 and running with the Bates line, N 88-15 W, 747 feet to an iron pin on the West bank of the North Saluda river; thence following said river as line (tie line, S 19-42 W, 898 feet) to an iron pin on the Bates line; thence with the Bates line, N 65-00 W, 356 feet to the corner of Tract 3; thence with the line of Tract 3, N 01-20 W, 304 feet to an iron pin; thence continuing with the line of Tract 3, N 15-00 W, 430 feet to the point of beginning, containing 10.3 acres, more or less, being all of Tract no. four (4) as shown on said plat.

The above described property is a part of the same conveyed to the grantor by deed of Susie B. Looper, Mae B. Bentley and M. G. Bates, November 16, 1951, recorded in the R. M. C. Office for Greenville County in Book 446, page 110, and is subject to right-of-ways or easements that may appear of record in regard to said property.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's (s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
