to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Glenn Hughey and his heirs and assigns forever:

All of that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, located near the City Limits of Greer, and southward therefrom, lying on the east side of Lee Circle, being shown as Lot No. 7 on a plat of property made for the Lee G. Smith Estate by H.S. Brockman, Surveyor, dated August 29, 1958, recorded in Plat Book MM, page 31, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING on a stake on the eastern margin of Lee Circle, joint corner of Lots Nos. 6 and 7 on said plat, and runs thence with the common line of said lots, S. 61-34 E. 192.3 feet to a stake on right-of-way of State Highway No. 14; thence N. 35-21 E. 50.5 feet to a stake; thence N. 32-07 W. 11.1 feet to a stake; thence N. 30-53 E. 45 feet to a stake, joint corner of Lots Nos. 7 and 8; thence with the common line of Lots Nos. 7 and 8, N. 61-34 W. 191.7 feet to a stake on the east side of Lee Circle; thence therewith S. 27-45 W. 100 feet to the beginning.
