to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said BRUCE H. MOSELEY, His, Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 25 of the property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of Glacier Street at the joint front corner of Lots 25 and 26 and running thence with the Eastern side of Glacier Street N 25-13 W 100 feet to a point at the joint front corner of Lots 24 and 25; thence N 64-47 E 162.5 feet to a point at the joint rear corner of Lots 24 and 25; thence S 25-13 E 100 feet to a point at the joint rear corner of Lots 25 and 26; thence S 64-47 W 162.5 feet to the joint front corner of Lots 25 and 26, the point of beginning.
