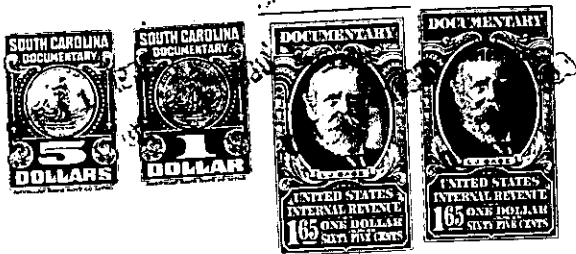
That DERBY HEIGHTS INC., a corporation in the State aforesaid,
