acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto
the said ODELL SHAVER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of
South Carolina, within the corporate limits of the City of Mauldin, and being known and designated
as Lot Number 97 of a subdivision known as Glendale, a plat of which is of record in the R. M. C.
Office for Greenville County in Plat Book QQ at Pages 76-77, and having the following metes and
bounds, to wit:

BEGINNING at a point on the Southeastern side of Fairfield Drive at the joint corner of Lots 97 and
107 and running thence with the Southeastern side of Fairfield Drive N 49-46 E 150 feet to a point;
thence following the curvature of the Southwestern intersection of Fairfield Drive with Banner Street
(the chord of which is S 85-14 E 35.3 feet) to a point; thence with the Southwestern side of Banner
Street S 40-14 E 23.8 feet to a point; thence continuing with the Southwestern side of Banner Street
