to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Burton H. Steele and Ollie M. Steele, their Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southern side of Highway No. 183 (also known as Farr's Bridge Road) and being known and designated as Lot No. 8 on plat of property of Lloyd Gilstrap recorded in the R. M. C. Office for Greenville County in Plat Book "OO", at Pages 66 and 67 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Highway No. 183 at the joint front corner of Lots Nos. 7 and 8, and running thence along the joint line of said lots, S. 38-30 E. 200 feet to an iron pin; thence S. 51-50 W. 100 feet to an iron pin; thence along the joint line of Lots Nos. 8 and 9, N. 38-30 W. 200 feet to an iron pin; thence along said Highway, N. 51-50 E. 100 feet to the point of beginning.
