Know All Men by These Presents:

That I, A.H. Campbell, in the State aforesaid,
 in consideration of the sum of Nine Hundred (\$900.00) - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Ralph R. Campbell and his heirs and assigns forever:

All that certain parcel or lot of land containing 4.50 acres, more or less, situated on the south side of the Camp Creek Road near the old Lenoah School, Highland Township, Greenville County, State of South Carolina, and having courses and distances according to survey and plat of the property of A.H. Campbell by W.P. Morrow, Registered Surveyor, dated April, 1953, as follows, to-wit:

BEGINNING at a stake on the south side of the Camp Creek Road, corner of the Odam land, and running thence along the Odam line, S. 36-15 W. 300 feet to an iron pin; thence S. 3-00 W. 372 feet to an iron pin on the branch; Jenkins line; thence up said branch S. 45 E. 47 feet, S. 76 E. 113 feet, S. 29 E. 26 feet, S. 70-30 E. 47.5 feet, S. 59-40 E. 82 feet and N. 62 E. 44 feet to an iron pin on Stokes line; thence along the Stokes line, N. 34-30 W. 228 feet to an iron pin; thence N. 42-10 E. 480 feet to an iron pin on the south side of said road; thence along the road, N. 58-50 W. 354 feet to the beginning corner.

This is the same property conveyed to A.H. Campbell by Mauritz Veneida Odom by deed recorded in Deed Book 454, page 288, and by deed of Cora H. Odom, et al., recorded in Deed Book 481, page 392, R.M.C. Office for Greenville County.

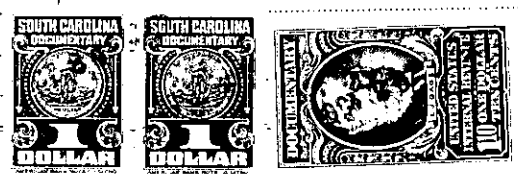
