Land Surveyor, dated Sept. 1960, with the said parcel of land being bounded on the north by Elizabeth Drive; on the east by the Batson property; on the west by a branch leading to Reedy River and on the south by properties belonging to the grantors with it being described by courses and distances as follows, to-wit:
