Know All Men by these Presents:

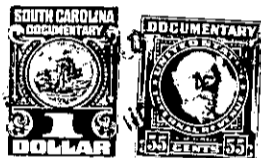
That J. W. Burns in consideration of the sum of Three Hundred and No/100 (\$300.00) in the State aforesaid, DOLLARS,
