Know All Men by These Presents:

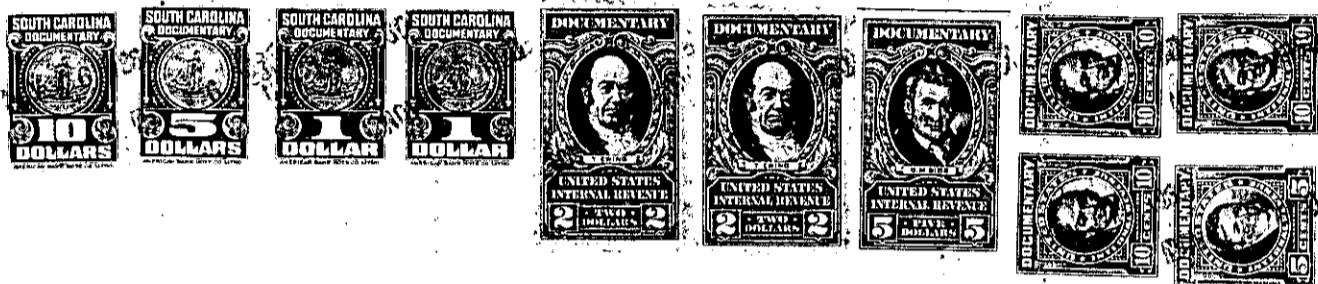

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gary H. Mullinax and Darlene H. Mullinax, their heirs and assigns:

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot 33 on plat of Pine Grove Heights Extention, recorded in Plat Book SS, Page 83, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Pine Grove Road, the joint front corner of Lots 32 & 33, and running thence N. 36-23 E., 151.2 feet to a point; thence S. 2-25 E., 200 feet to an iron pin on the northeasterly side of Pine Grove Road; thence with the northeasterly side of said Road N. 48-10 W., 87.9 feet to an iron pin; thence still with said Road N. 59-35 W., 38 feet to the point of beginning.
