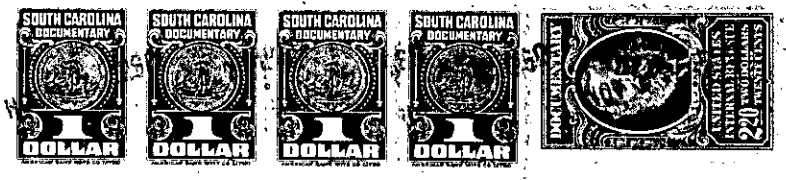
HORACE L. MAULDIN, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 27 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Glacier Street at the joint corner of Lots 27 and 28 and running thence with the Southwestern side of Glacier Street S 25-13 E 103.9 feet to a point; thence following the curvature of the Northwestern intersection of Glacier Street with Lawnview Court (the chord of which is S 15-13 W 32.4 feet) to a point; thence with the Northwestern side of Lawnview Court S 55-40 W 143.3 feet to a point at the corner of Lot 27; thence N 25-13 W 151.3 feet to a point at the joint rear corner of Lots 27 and 28; thence N 64-47 E 162.5 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.
