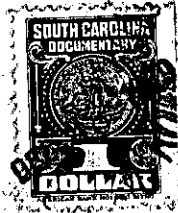

Patton**, in hand paid by **Christ Church Cemetery, a corporation**, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell and release unto the said **Christ Church Cemetery** a lot or parcel of ground, including perpetual care, in Christ Church Cemetery, Greenville County, South Carolina, designated as Lot No. 18 Section 39 ; the same being described and designated as above, in accordance with plat recorded in

R. M. C. Office for Greenville County in Plat Book H page 300. **Being one of the lots conveyed to me by Christ Church Cemetery (Deed Book 179, Page 23, 10/27/44).**

It is distinctly understood that said lot is to be used exclusively for the burial of human bodies of the white race, and is sold and conveyed subject to all rules and regulations printed on the back hereof, and any additions or amendments for the government of the Cemetery which may hereafter be adopted.

TO HAVE AND TO HOLD the above granted property to the said **Christ Church Cemetery, its successors**

~~and assigns forever~~; subject, however, to the restrictions and limitations above referred to. **grantor herself and her heirs, executors and administrators** AND ~~Christ Church Cemetery~~ does hereby, bind ~~to warrant and forever defend the~~ said premises to the said **Christ Church Cemetery, its successors, grantor and grantor's heirs, executors and administrators,** against ~~all and singular persons~~, and against every person whomsoever lawfully claiming or to claim the same or any part thereof; subject, however, to the restrictions and limitations herein contained.
