All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, near the corporate limits of the Town of Simpsonville and being Lot No. 1 of the Howard Subdivision, plat of said subdivision made by L. C. Godsy Survey in April, 1956, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of State Highway No. 417, joint corner with the land of George W.
