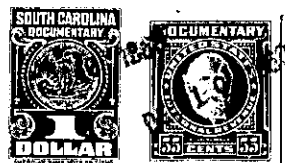
That T. J. Barbrey in the State aforesaid, in consideration of the sum of Ten Dollars and other considerations DOLLARS,
