ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the Southern side of Parisview Avenue in the City of Travelers Rest, Bates Township, Greenville County, South Carolina, being shown and designated as Lot No. 15, according to a plat of Sunny Acres made by J. C. Hill, Surveyor, August 24, 1953, (revised 1 March 1954), recorded in the R.M.C. Office of Greenville County, South Carolina, in Plat Book "BB", at Pages 168 and 169, reference to said plat being craved for a more complete and detailed description thereof.
