That B. F. Reeves in the State aforesaid, in consideration of the sum of six hundred DOLLARS,

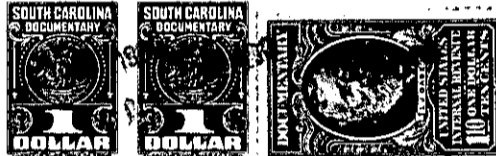

Smith and Lois C. Smith and their heirs and assigns

ALL that certain piece, parcell or lott of land, with the improvements thereon, lying being and situate in Austin Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 44 of B. F. Reeves Subdivision in accordance with Plat made by H. S. Brockman, dated September 14, 1958, and recorded in the R. M.C. office for Greenville County in Plat Book "00", Page 190, and being more fully described according to said Plat, to-wit:

BEGINNING at an iron pin at the intersection of Reeves Drive and Dianne Avenue and running thence along Reeves Drive N. 20-50 W. 191.2 feet to an iron pin; thence N. 49-29 E. 55.5 feet to an iron pin; thence S. 40-54 E. 180 feet to an iron pin on the edge of Dianne Avenue; thence along Dianne Avenue S. 49-29 W. 121.6 feet to an iron pin, being the point of beginning.
