Ayers Estate, the said survey having been made by R. K. BEGINNING at an iron pin on a 50 foot road joint front corner of tracts 9 and 11 running thence along said joint front line N. 24-30 W., 451.6 feet to an iron pin running thence N. 65-30 E., 457 feet to an iron pin and joint rear corner of tracts 11 and 13; running thence S. 24-30 E., 451.6 feet to an iron pin on a 50 foot road and running thence along said 50 foot road S. 65-30 W., 457 feet to an iron pin, the beginning corner.
