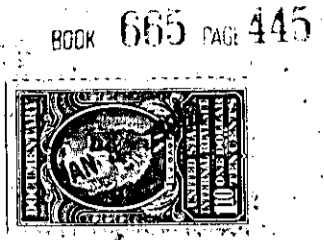

KNOW ALL MEN BY THESE PRESENTS, that I, Walter W. Goldsmith

in consideration of Six Hundred Sixty-five, -----(\$665.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto M. W. Fore, his heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as lot 483 on Burmaster Drive, in Section D of Englewood Estates, as shown by a plat thereof, dated February 1955, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book BB, at page 176, and having the following metes and bounds:

BEGINNING at an iron pin on Burmaster Drive at joint front corners of lots 484 and 483 and running N. 86-43 W. 75 feet to an iron pin on said Drive, joint front corners of lots 483 and 482; THENCE with the line of lots 483 and 482 S. 3-15 W. 274.5 feet to an iron pin at rear corners of lots 483 and 482; thence S. 83-35 E. 75.02 feet to an iron pin at rear corners of lots 483 and 484; thence with the line of lots 483 and 484 N. 3-15 E. 276.2 feet to an iron pin on Burmaster Drive, the point of beginning.

RESTRICTIONS: This property shall not be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence shall cost less than \$8500; no residence shall be erected nearer than 50 feet to the front line and no residence shall be erected on said lot unless it have 50 feet, or more frontage. No outside toilets are permitted; sewage must be disposed of by approved septic tanks.

GRANTEE hereinto pay taxes for the year 1960.

This property is conveyed subject to any rights of way now in existence.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
