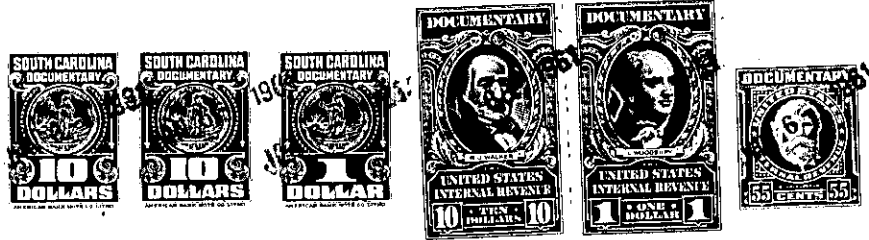
KNOW ALL MEN BY THESE PRESENTS, that JEANNE G. MCILWAIN
