Know All Men by These Presents:

That I, J. Frank Williams in the State aforesaid, in consideration of the sum of Two Thousand, Five Hundred (\$2,500.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James B. Arrowood, his heirs and assigns, forever:

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 47 of Western Hills, plat of which is recorded in Plat Book QQ, pages 98 and 99, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Alice Farr Drive at joint front corner of Lots Nos. 46 and 47, and running thence with line of said lots, N. 8-21 W. 162.4 feet; thence S. 74-48 W. 125.8 feet; thence S. 21-04 E. 164.8 feet to an iron pin on Alice Farr Drive; thence with Alice Farr Drive, N. 68-56 E. 31.8 feet to a bend; thence continuing with Alice Farr Drive, N. 74-39 E. 58.2 feet to the point of beginning.

ALSO:

ALL that certain other lot being known as Lot No. 147 of Western Hills, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Alice Farr Drive at joint front corner of Lots Nos. 146 and 147, and running thence with the line of said lots, S. 11-04 W. 257.5 feet; thence N. 73-50 E. 78.3 feet; thence N. 23-30 E. 206.4 feet to an iron pin on Alice Farr Drive; thence with Alice Farr Drive, N. 66-30 W. 66.2 feet to bend; thence continuing with Alice Farr Drive, N. 72-22 W. 50 feet to the point of beginning.

This conveyance is made subject to the easements as shown on said plat, and the recorded restrictions applicable to Western Hills.
