Know All Men by These Presents:

That I, J. P. TRAYNHAM in the State aforesaid, in consideration of the sum of Two Thousand Five Hundred and no/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said GEORGE H. PRUITT and WYNONA T. PRUITT, their heirs and assigns, forever:

ALL that lot of land situate at the Northwest corner of the intersection of Patrol Club Road and Fairway Court, near the City of Greenville, in Greenville County, S.C., being shown as Lot No.1 on plat of property of J.P. Traynham, Sr. recorded in Plat Book UU, Page 125, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Northwest corner of the intersection of Patrol Club Road and Fairway Court, and runs thence along the North side of Fairway Court, S. 75-03 W., 191.4 feet to an iron pin; thence with the line of Lot 2, N.36-44 W., 250 feet to an iron pin; thence N. 49-29 E., 283.5 feet to an iron pin; thence S. 88-01 E., 50 feet to an iron pin on the West side of Patrol Club Road; thence along Patrol Club Road, S. 8-01 E., 100 feet to an iron pin; thence still along Patrol Club Road, S. 13-19 E., 240.9 feet to the beginning corner.

THIS PROPERTY is subject to the restrictions applicable to Club View Heights recorded in the RMC Office for Greenville County, S.C. in Deed Book 536, Page 413, and subject to the further restrictions that no dwelling should be erected on said lot nearer than the set-back line shown on the recorded plat and that no dwelling shall be constructed on said lot costing less than \$20,000.

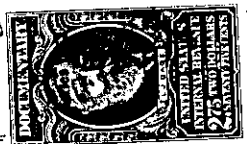
