to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Augustus A. Huddleston, his heirs and assigns forever:

All that certain piece, parcel or lot of land in Austin Township, Greenville County State of South Carolina, within the corporate limits of the City of Mauldin, and being known as lot 94 of a subdivision known as Glendale, a plat of which is of record in the R.M.C. Office for Greenville County in plat book QQ at pages 76-77, and having the following metes and bounds, to-wit:

Beginning at a point on the southeastern side of Fairfield Drive at the joint corner of lots 93 and 94 and running thence with the southeastern side of Fairfield Drive S 49-46 W, 155 feet to a point; thence following the curvature of the southeastern intersection of Fairfield Drive with Banner Street (the chord of which is S 04-46 W, 35.3 feet) to a point; thence with the northeastern side of Banner Street S 40-14 E, 23.8 feet to a point; thence continuing with the northeastern side of Banner Street S 59-03 E, 78.4 feet to a point; thence with the northern side of Banner Street S 77-53 E, 116.2 feet to a point at the joint corner of lots 94 and 95; thence N 12-07 E, 105.8 feet to a point at the joint corner of lots 93, 94, and 95; thence N 40-14 W, 150 feet to the point of beginning. Being the same property as conveyed the grantor by deed of Wm. R. Timmons, Jr. dated January 30, 1961 and to be recorded.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

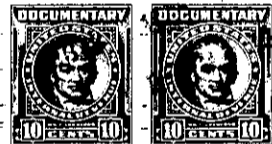
