Know All Men by These Presents:

That I, JAMES W. MITCHELL

in consideration of the sum of Sixteen Hundred Eighty Nine and 60/100 -----DOLLARS, and assumption of mortgage referred to below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said RAYMOND HULME and TAMARA S. HULME, their heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the Northeast side of East Circle Avenue, in the City of Greenville, in Greenville County, South Carolina, being shown as a portion of Lots 23 and 24, on plat of East Lake Subdivision, made by Dalton & Neves, Engineers, June 1928, recorded in the RMC Office for Greenville County, S. C. in Plat Book G, pages 228 and 229, and having according to said plat and a recent survey made by Dalton & Neves, May 1958, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northeast side of East Circle Avenue, in the front line of Lot 24, said iron pin being located 240 feet West, measured along East Circle Avenue from the intersection of East Circle Avenue and Erskine Street and runs thence through Lot 24, N. 37-15 E., 158.9 feet to an iron pin on the Southwest side of Erskine Street; thence along said street, N. 53-22 W., 75 feet to an iron pin; thence through Lot 23, S. 37-15 W., 158 feet to an iron pin on the Northeast side of East Circle Avenue; thence along the Northeast side of East Circle Avenue, S. 52-45 E., 75 feet to the beginning corner.

The grantee assumes and agrees to pay the balance due on that mortgage given by William R. Speacht to Canal Insurance Co. on May 17, 1958, in the original amount of \$12,800.00, recorded in the RMC Office for Greenville County, S. C. in Mortgage Book 747, page 185.

This is the same property conveyed to the grantor by deed of William R. Speacht dated May 16, 1959, recorded in above RMC Office in Deed Book 625, page 81. Grantee to pay 1961 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and Their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
