KNOW ALL MEN BY THESE PRESENTS, that I, Lillie Marie Mize

in consideration of Fifty & No/100 (\$50.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Jack S. Mize, his heirs and assigns forever:

ALL that piece, parcel or lot of land in Chick Springs Township, being known and designated as Lots Nos. 72 and 73 of a subdivision known as Holly Vista, as shown by a Plat thereof, dated February 1956, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 191, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Woodbriar Road, joint front corners of Lots Nos. 71 and 72 and running thence along the line of said lots, N. 51-25 W. 220 feet to iron pin; thence running with rear line of Lot 72, 53 feet to iron pin rear corner of Lot 76; thence running with rear line of Lots 75 and 76, 124.3 feet to iron pin rear corner of Lot 74; thence running with line of said lot, S. 51-25 E. 110.9 feet to iron pin on Woodbriar Road; thence running with said Road, 100 feet to iron pin at point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet, or more, frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.
