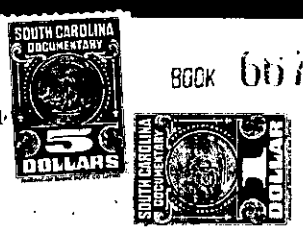

Savings & Loan Assn. in amount of \$8,990.66 to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Keller Wells and Betty C. Wells, their Heirs and Assigns forever:

ALL that certain piece, parcel or lot of land, with the improvements thereon, lying, being and situate in Austin Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 43 of B.F. Reeves Subdivision in accordance with plat made by H. S. Brockman, dated September 14, 1958, and recorded in the R.M.C. Office for Greenville County in Plat Book "00", Page 190, and being more fully described according to said plat, to-wit:

BEGINNING at an iron pin on the northern side of Dianne Avenue, joint front corner of Lots Nos. 44 and 43 and being 121.6 feet from the intersection of Dianne Avenue and Reeves Drive and running thence N. 40-54 W. 180 Feet to iron pin; thence N. 49-29 E. 80 feet to iron pin; thence S. 40-54 E. 180 feet to iron pin on Dianne Avenue; thence along Dianne Avenue S. 49-29 W. 80 feet to iron pin, being the point of beginning.
