"LESS, HOWEVER, THE FOLLOWING:

(1) Those lots of land heretofore conveyed to the grantee, known as Lots Nos. 4, 5, 6, 8, 9, 10, 15, 19, 20, 22, 23, 24, 25, 26, 31, 36, 37, 42 and 105, as shown on plat of Botany Woods, Sector I, recorded in Plat Book QQ at Page 78.

(2) Those lots of land heretofore conveyed to the mortgagor, known as Lots Nos. 47, 48, 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64, 66, 67, 68, 69, 72, 74, 75, 76, 77, 78, 79, 80, 84, 85, 86, 87, 88, 89, 90, 91, 92, 93, 94 and 95, as shown on plat of Botany Woods, Sector II, recorded in Plat Book QQ at Page 79.

(3) Those lots of land heretofore conveyed to the mortgagor, known as Lots Nos. 126, 133, 145, 140, 154, 166, 167 and 168, as shown on plat of Botany Woods, Sector III, recorded in Plat Book RR at Page 37.

(4) That triangular lot heretofore conveyed by the grantors to William L. Costner by deed recorded in Book of Deeds 651 at Page 546, being the northwestern corner of Lot No. 100 of Botany Woods, Sector I, recorded in Plat Book QQ at Page 78, and also a portion of property lying to the north of said lot and also a triangular lot adjoining said lot.
