

POWER OF ATTORNEY - LIMITED

KNOW ALL MEN BY THESE PRESENTS:

That I, Henry W. Myers, a legal resident of the City (Town) of Greenville, County of Greenville, State of South Carolina, United States of America, ~~do hereby certify that I am the owner of the property described herein and that I have the right to execute this instrument~~ have made, constituted and appointed and by these presents do make, constitute and appoint Esso Myers whose address is 309 Pinafield Dr., Greenville, South Carolina, my true and lawful attorney to act in, manage, conduct, concur with persons jointly interested with myself therein, and do all or any of the following acts, deeds, and things, that is to say: **to sell, transfer and convey all my right title and interest in the real estate located at 309 Pinafield Drive, Greenville, South Carolina, the same being a house and one lot in Greenville County, State of South Carolina and to execute in my name and documents including valid receipts, deeds and agreements to facilitate the conveyance of the above described real property. GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act, deed, matter, and thing whatsoever in the premises, as fully and effectively to all intents and purposes as I might or could do in my own proper person if personally present; and hereby ratify all that my said attorney shall lawfully do or cause to be done by virtue of these presents.

And I hereby declare that any act or thing lawfully done hereunder by my said attorney shall be binding on myself, and my heirs, legal and personal representatives and assigns; whether the same shall have been done before or after my death or other revocation of this instrument, unless and until reliable intelligence or notice thereof shall have been received by my said attorney; and whether or not I, the grantor of this instrument, shall have been reported or listed, either officially or otherwise, as "missing" or "missing in action" as those words are used in military parlance, it being the intent hereof that such status designation shall not bar my attorney from fully and completely exercising and continuing to exercise any and all powers and rights herein granted, and that such report of "missing" or "missing in action" shall neither constitute nor be interpreted as constituting notice of my death nor operate to revoke this instrument.
