TIMMONS, JR., in the State aforesaid, in consideration of the sum of ONE THOUSAND FIVE HUNDRED AND NO/100---(\$1,500.00)--- DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and-released, and by these presents do grant, bargain, sell and release unto the said CLYDE L. DORR

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 12 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of Noble Street at the joint front corner of Lots 11 and 12 and running thence with the Eastern side of Noble Street S 2-50 W 100 feet to a point at the joint front corner of Lots 12 and 13; thence S 87-10 E 133 feet to a point at the joint rear corner of Lots 12 and 13; thence N 14-46 E 102 feet to a point at the joint rear corner of Lots 11 and 12; thence N 87-10 W 154.1 feet to the point of beginning.
