ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 25 on a plat of Western Hills, recorded in Plat Book QQ at Pages 98-9, and having, according to said plat, the following metes and bounds, to-wit:
