All that piece, parcel or lot of land, containing one acre, more or less, situate, lying and being on the northerly side of a certain county road running in an westerly direction 853 feet from the Scuffletown Road, about one and one-half miles from the Town of Simpsonville, Greenville County, South Carolina, having according to a plat prepared by Jones & Sutherland, Engineers, dated June 8,1959, entitled "Property of Perry Giles, Simpsonville (Greenville Co.) S.C.", the following metes and bounds, to wit:

Beginning at an iron pin in the center of a certain county road, the same being located 853 feet in a westerly direction from the center of the Scuffletown Road, and running thence N. 12-15 W. 160.0 feet to an iron pin; thence N. 53-04 W. 81.6 feet to an iron pin; thence S. 88-45 W. 140-0 feet to an iron pin; thence S. 1-15 E. 208.0 feet to an iron pin in the center of the above referred to county road; thence along the northerly side of the said county road N. 88-45 E. 235.0 feet to the beginning corner.

This being the same property conveyed to the grantor by a deed recorded in the RMC Office for Greenville County in Deed Book 631 at page 352. The grantor agrees to pay the 1961 taxes. As part of the consideration hereto the grantee assumes and agrees to pay the remaining balance due on a certain mortgage in favor of Modern Homes Construction Co. recorded in mortgage book 799 at page 201.
