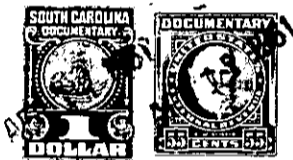
That We, M. A. Jordan and Mae Jordan in the State aforesaid, in consideration of the sum of Two Hundred Fifty DOLLARS,
