Certificate of Ownership

KNOW ALL MEN BY THESE PRESENTS:

THAT THE BETHEL METHODIST CHURCH CEMETERY, being an Arm of the Bethel Methodist Church located near Simpsonville, South Carolina, in consideration of the sum of thirty Dollars and no/100 (\$ 30.00) to it in hand paid, receipt of which is hereby acknowledged, does hereby grant and convey unto Lucy G. McKittrick heirs and assigns for interment purposes only, subject to the conditions, reservations and restrictions hereinafter contained, the following property situate in "an addition to" the Bethel Methodist Church Cemetery in Greenville County, State of South Carolina, described as lot number 5 in block number W according to a map of the same made by C. O. Riddle, Registered Land Surveyor, on July 18, 1959, and filed in the offices of the Bethel Methodist Church. The said lot or lots are more definitely described as follows:

Lot no. 5 in block W, situated on the South side of the center driveway, being the fifth plat from Gate A of the cemetery, in the first row of plats.

THAT THIS CONVEYANCE, and all right, title and interest hereby conveyed in the said property above described, is, and at times shall be limited to a right of interment only therein or thereupon, and is subject at all times to the rules and regulations of the said Bethel Methodist Church, on file in its office, now existing or which may be by the said Church hereafter adopted either by amendment alteration or the adoption of new regulations, and which are specifically referred to and herein inserted as if set forth in full, with all such conditions, reservations and restrictions being binding upon the grantee herein, his or her heirs, devisees, executors, administrators and assigns.

Nothing herein contained shall be deemed to restrict the use of any other portion of said cemetery. Only the grantor or its successors, in interest of the fee title may enforce any restrictions heretofore or hereafter placed upon the use of any portion or section of said Cemetery.
