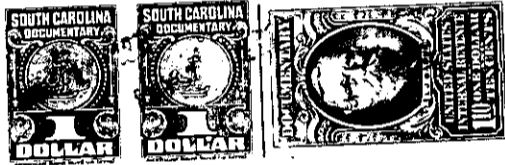

C.; in Plat Book KK, page 107, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the South side of Knollview Drive at the joint front corner of Lots 90 and 91, and running thence with the line of Lot 90, S. 11-16 W., 197.8 feet to an iron pin; thence S. 85-57 E., 100.76 feet to an iron pin; thence with the line of Lot 92, N. 11-16 E., 184.8 feet to an iron pin on the South side of Knollview Drive; thence with the South side of Knollview Drive, N. 78-44 W., 100 feet to the point of beginning.
