That I, JOHN W. HARRIS in the State aforesaid, in consideration of the sum of Ten and no/100 (\$10.00) ----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. L. MANN, his heirs and assigns, forever:

ALL that certain piece, parcel or lot of land in the County of Greenville, South Carolina, near Woodside Cotton Mills, being known and designated as Lot "C" according to a plat of Woodside Mills, Greenville, South Carolina, prepared by Pickell & Pickell, Engineers, March 7, 1950. and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point in the Northern side of East South Sixth Street at the joint corner of Lots "B" and "C", which point is 100 feet West of the Northwestern intersection of Vance Street and East South Sixth Street, and running thence with the joint line of said lots, N. 15-49 E., 100 feet; thence N. 74-11 W., 75 feet to a point, joint rear corner of Lots "C" and "D"; thence with the joint line of said lots, S. 15-49 W., 100 feet to a point in the Northern side of East South Sixth Street; thence with the Northern side of said Street, S. 74-11 E., 75 feet to the beginning point.
