to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

WILLIAM T. OWENS and ALICE N. OWENS, their heirs and assigns, forever:

ALL that piece, parcel or lot of land, situate on the North side of Riverview Drive, near the City of Greenville, in Greenville County, South Carolina, shown as Lot No. 32 on Plat of Riverdale, made by Dalton & Neves, Engineers, July, 1957, recorded in the RMC Office for Greenville County, S. C., in Plat Book KK, page 107, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the North side of Riverview Drive, at the joint front corner of Lots 31 and 32, and running thence with the line of Lot 31, N. 9-09 W., 279 feet to an iron pin at the high water mark of the Saluda River; thence traversing the high water mark of the Saluda River, S. 68-40 W., 168.8 feet to an iron pin; thence with the line of Lot 33, S. 23-35 E., 256.5 feet to an iron pin on the North side of Riverview Drive; thence with the curve of Riverview Drive (the chord being N. 75-39 E., 50 feet) to an iron pin; thence continuing with Riverview Drive, N. 80-51 E., 50 feet to the point of beginning.

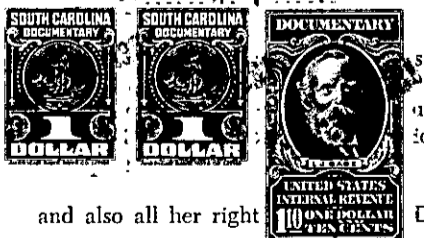
