all that piece, parcel or lot of land situate, lying and being in the County and State aforesaid, Bates Township, town of Marietta, on the N/S of Slater Road, being shown and designated as Lot no. six (6) on a plat of survey made by T. T. Dill, surveyor, January 26, 1961, entitled "Plat of Property of Jessie S. Baker", and having, according to said plat, the following metes and bounds, courses and distances, to-wit:
