Arrowood, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 117 on Plat of Western Hills recorded in the R. M. C. Office for Greenville County in Plat Book QQ, Pages 98-9, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Alice Farr Drive at the joint front corner of Lots 116 and 117, and running thence with the common line of said Lots, S. 23-30 E. 174.1 feet to an iron pin; thence N. 65-21 E. 100 feet to an iron pin; thence N. 23-30 W. 171.4 feet to an iron pin on the southerly side of Alice Farr Drive; thence with said Drive, S. 66-30 W. 100 feet to the point of beginning.
